1. Apply online to the University via CAL STATE APPLY

- Submit the graduate application and fee at www.calstate.edu/apply (Required)
- Send one set **OFFICIAL academic transcripts** from all undergraduate and graduate institutions from which you have received course credits.

2. Send the following REQUIRED DOCUMENTS directly to the MPA Program Coordinator

- One set of **UNOFFICIAL academic transcripts**
- Personal Statement**
- Two letters of recommendation (can be sent directly from recommenders via mail or email)**
- Current professional resume**

International Students must also submit:

- Translated copies of transcripts from any previous colleges and/or universities that you have attended.
- The CSUF **financial affidavit** signed by your financial sponsor. <http://international.fullerton.edu/admissions/costs/>
- A **bank statement** from your financial sponsor's bank (dated within the last year), indicating sufficient funds.
- A copy of your current I-20 and/or I-94, if you are currently in the United States.
