CORRELATED CURRICULUM

Three courses (9 units) in the related fields shall be selected by the student from this list. The purpose of this requirement fourfold: 1) to provide students with an enhanced appreciation of ethnic, cultural diversity, 2) to broaden the intellectual context for materials learned in Criminal Justice, 3) to provide students interested in law school with appropriate pre-law preparation, and 4) to provide students with appropriate skill-building courses, such as those featuring computer methods.

These courses are not intended to duplicate the courses offered within Criminal Justice.

Exceptions to the courses listed below (including new or special elective courses not listed in the catalog) are allowed only upon consultation with an advisor.

Noted courses are particularly suitable for students who are interested in Law School (LAW), Law Enforcement (LE) or Corrections (CORR).
