- Importance of pronouns
 - Less descriptive ways that we identify ourselves
 - Words that we use in place of our names (he/him/his)
 - Allows people to feel validated with their identity when referring to them
 - o Do not assume you could default to they/them/theirs
 - o It communicates that you are an ally
 - He/him/his/himself, she her hers herself, they/them/theirs/themselves
 - Ze/zir/zirs/zirself,
 - What is the difference between ze and they—it's up to the person, they want to distinguish it because they/them could be plural
 - Share pronouns to open the door for others to share
 - No longer saying preferred pronouns because they are not a preference, its someone's identity
 - o What happens when you mess up?
 - Apologize for using the incorrect pronoun, and then correct yourself
- DIRC, 5 different identity resource centers
 - o Great resources for students
 - Do not need to identify with centers to use them
- Safe space training is provided by resource center

 - Having a discussion in governance regarding GPA for ASI positions, 2.5 GPA is needed, this could exclude some positions
 - Wants some feedback from us
 - Thinks 2.5 is appropriate, leaderships positions are something we take on
 - Understands having general standards to see who will be a good fit but sees that GPA does not correspond with fitness for being a student leader, in favor of lowering the GPA
 - Understand the need for limits but sometimes things happen and we should have a system that
 - Believes things do happen in life, there could be a grace period system, is there something like that in place?
 - No, there is a system that allows students to ask the BOD for the opportunity
 - A grace period is better, going to peers for an opportunity could be shameful
 - It is pretty cutthroat to use the student's GPA as these leadership positions could allow people to grow
 - Agrees that GPA does not reflect leadership, you could have a good GPA and be a terrible leader, we need to approach this more realistically, how are we coming up with a system that takes into account their characteristics of leaders other than GPA?
 - o For ASI students vote for their leaders, but we could implement a system that checks in on students, leaders' academics are overlooked when they are in positions
 - Grace period is fine but we have to be there for those students, it already brings student down if students are removed from the position
 - Has spoken to different communities—such as the undocumented community—and they struggle with academics when they have a lot going on in their lives

- Although the GPA being lowered is a good cushion, if the other issues that are affecting their GPA isn't addressed then what's the use of lowering the GPA
- Information is very inconsistent there are 3 GPA's, consider which GPA is the one that should be used because sometime only one of the GPA's is being used, one semester could be bad and be used when you overall could be in good standing, if going off of 1 term then it is not fair, we should be consistent across the board
- People get stipends for the positions but not for CR, org/club board members should also receive stipends as running an org is like a job, stipends do not align with CA minimum wage
- It makes sense to look at the cumulative over term for leadership roles, sometime it would make sense to look at term if GPA has been consistently bad
- If the GPA is the problem, because sometimes students have a low GPA but they are ok with having positions, they should seek advice to see if maybe they need to step down
- Being involved is overwhelming so students should be approached to see if they are ok with reaching the minimum GPA or if they need to step down from what they are involved in
