This included building a structure to incorporate students, faculty, University Government Relations, and University Advancement into a plan to establish a curriculum, a faculty selection process, strong working relationships with a wide variety of internship offices in D.C., and sufficient outside financial support to fund the program. The program has been highly successful with a growing number of campuses and students involved in these experiences. We also established and continue to build an endowment to provide a stable financial base for the program.

In cooperation with the Dean's office and our alumni, I helped create and serve as Founding Director of the *Cal State DC Scholars Program*. The program started as a summer only program and has grown into a program for both the summer term and the spring semester. The program has expanded to include students from a wide variety of majors across various colleges at CSUF and to include students from other CSU campuses including Northridge, Dominguez Hills, San Marcos, Sonoma, Chico, San Francisco, San Diego, and Pomona.

As Founding Director, I am responsible for programmatic issues, developing and implementing a plan to prepare students for their experiences, outreach to D.C. offices, and collaborate with University Advancement for fundraising to support the program and give financial assistance directly to the students. Over 400 students have participated in the program over the years and we have built a strong and supportive alumni network both on the west coast and in Washington, D.C. as a result of the program. This role provided me with opportunities to work with the greater University community such as our Office of Government Affairs, University Advancement, Associated Students, and a wide variety of governmental and nongovernmental offices in Washington, D.C.
